Carefully read the table below to see the requirements to join and the benefits you will earn.

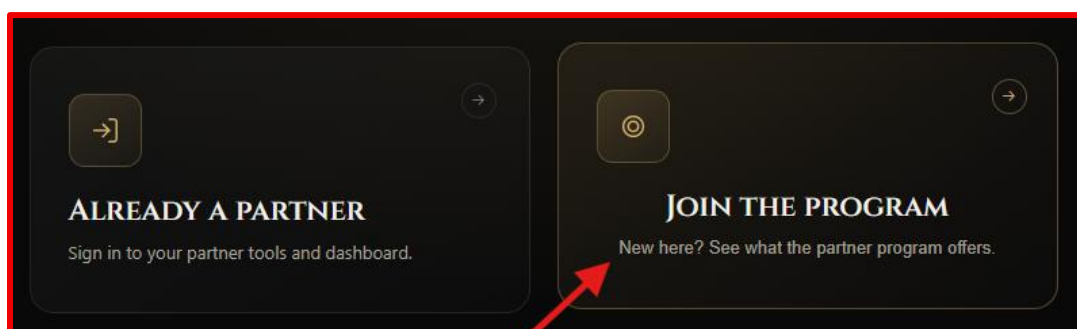
2. Requirements to join

The table below lists all requirements that need to be met. If every requirement is fulfilled, you may send your partner program join request via

List of requirements	
▶	At least 15 recurring visitors per stream
▶	No production of gambling content or any prohibited content <i>*see list on page 2</i>

Once you visit the mentioned website, you may start your request by pressing "Join the program".



3. Prohibited content

Consult the below list to see whether content you produce or might have produced in the past falls into the category “prohibited content”. This list was gathered by Convence and may be subject to changes. Items might be added or removed from the list.

List of prohibited content	
	Hate speech or hateful content targeting people based on race, ethnicity, nationality, religion, gender, sexual orientation, disability, or other protected characteristics.
	Extremist or terrorist content , including propaganda, recruitment, glorification, or support for extremist or terrorist organizations.
	Violent or graphic content , particularly content that glorifies, celebrates, or encourages real-world violence.
	Sexually explicit or pornographic content , including explicit sexual imagery or videos.
	Sexual exploitation or sexualization of minors , in any form.
	Harassment, bullying, or targeted abuse , including persistent attacks against individuals or communities.
	Threats or encouragement of violence , including credible threats against individuals, groups, or organizations.
	Drug-related content that promotes or facilitates the use, sale, or distribution of illegal drugs.
	Self-harm or suicide-promoting content , including content that encourages, glorifies, or provides instructions for self-harm or suicide.
	Dangerous challenges or activities that encourage viewers to seriously endanger themselves or others.
	Doxxing or malicious disclosure of private information , including publishing someone's personal information without their consent.
	Scams, fraud, or deceptive schemes , including content designed to defraud, manipulate, or financially exploit viewers.
	Malicious or deceptive content , including deliberate impersonation, phishing, malware distribution, or similar activities.
	Content encouraging discrimination or dehumanization of individuals or groups.
	Non-consensual intimate content or content intended to sexually exploit, humiliate, or expose another person.
	Repeatedly offensive or intentionally shocking content whose primary purpose is to provoke, harass, or disturb rather than entertain or inform.

4. After Submission
